We are writing to you as a Shareholder of the Company to advise of the following change to the supplements (the “**Supplements**”) for the Company for each of the sub funds below which will take effect as at 30 November 2020 (the “**Effective Date**”).

**1. Changes to Indices**

In order to seek to ensure the Funds can continue to efficiently track the desired index exposure in the future, the Directors have determined to replace the indices tracked by the Funds, as indicated in the table below. The Directors consider that the new indices will offer similar diversification benefits to as the existing indices, through limiting over concentration in the top holdings as well as targeting a more balanced exposure across the portfolio securities. The new index aims to ensure that the largest constituent cannot exceed 35% of the index, and the second largest constituent cannot exceed 20% of the index.

The Funds will continue to track their existing Index until the Effective Date, and will then track the new Index.


