These amendments are expected to be noted by the Central Bank on or about 20 February 2024.

This notice summarises the proposed changes to the Prospectus and the Supplements and shareholders are encouraged to refer to the Prospectus and the Supplements for further details.

# 1. Changes to the Prospectus

The Prospectus has been amended to reflect updates in the Investment Manager's ESG Policy. The updated disclosure provides further detail as to the Investment Manager's commitment to diversification and responsible investment. It also describes the function of the Investment Manager's Stewardship Committee in respect of the Investment Manager's investment related activities.
